Sir,

This is in continuation of the Board's earlier communications subject cited above. The Board is in the process of reviewing the status and progress of finalization of results of this examination by the various participating institutes.

We have vetted the merit / reserve list received from 24 institutions so far. The final draft list(s) is awaited from 31 institutions as on date.

Meantime, the Board is in receipt of some representations from such of those applicants who had applied for more than one institute for the same position. In spite of specific instructions to all the candidates and also to the Centre Supervisors regarding an option to be obtained and forwarded to the Board from such of these applicants, it has now emerged that some of the applicants had provided incomplete/factually incorrect information in these options and a few had not complied with these instructions inadvertently or due to ignorance.

Nevertheless, to provide a fair and just opportunity to all such applicants, the Board has decided that all the participating institutions shall upload the marks of all the candidates who had actually appeared in the centre(s) of particular institute **immediately for information and reference till 28.02.2018.**

The list of applicants whose OMR answer sheets could not be evaluated due to incomplete details in the OMR sheet, as forwarded by the Board may also be displayed for information and reference.

Sub : **Important information regarding declaration of results of the Technical Assistant (T-3) Examination conducted by the Board on 17th July, 2016**

The Agricultural Scientists Recruitment Board (ASRB) had been given the responsibility for conducting a common written examination for filling up positions of Technical Assistant (T-3) in 55 Research Institutions of the Indian Council of Agricultural Research (ICAR).

A Common Written Examination was held on 17th July, 2016 (Sunday) from 10.00 a.m. to 12.00 noon in 27 Centres spread all over the country.

In response to the individual advertisements issued by these research institutions on different dates, some aspirants were candidates for more than one of these institutes. Such candidates had received the admit-card for this examination from all the institutes where he/she had applied and had been given the option to appear at any one of the Institute / Centre of his/her choice.

All such aspirants who had applied for more than one institution were instructed to provide his/her preference / option in order of priority of all the institutions for which he/she had applied and hand it over to the Centre Supervisor on the day of Exam. Such aspirants were to be considered according to his/her merit in each of the institutions of his/her choice in the order of his/her preference subject to the rank/placement in the merit list of the relevant institution.

Accordingly, the Board had compiled all such options as received from the concerned Centre Supervisors and the complete list of all such applicants for more than one institution had been forwarded to all the participating institutions to cross check and verify before finalising and forwarding the draft merit / reserve list for final vetting by the Board. This exercise is essential so that none of the applicants who might have scored higher marks but might have appeared from another Centre and have opted for a particular institute, is not deprived of their fair opportunity as per their merit. In compliance, some of the institutions have forwarded the merit / reserve list to

Further, all the institutes irrespective of the fact whether the Board has vetted the results or otherwise may upload the draft merit/reserve list alongwith all the details of the recommended candidates in their websites.

In the rare event of an applicant having scored higher marks than the applicant finally recommended for an institution for which he had opted feels he/she left out in the draft merit/reserve list, he/she may bring it to the notice of the concerned Director of the institution alongwith all supporting documents like admit card etc. to establish his/her claim **on or before 28.02.2018.**

A Notification in this regard has been posted in the website of the Board. A copy of the same is enclosed for ease of reference. The same may also be displayed on your Institute's website.

Accordingly, it is requested that immediate steps may be taken to display the mark-lists of all the applicants of the centre(s) of your institute immediately and also upload the draft merit / reserve list in the website for information of all concerned. In case of receipt of representations in this regard, the same may be considered and after due diligence, necessary amendments may be carried out, if required and the same forwarded to the Board for vetting.

The entire exercise should be completed by 31st March, 2018 failing which the Board shall not entertain any further requests or proposals for vetting concerning this examination.

Therefore, it is for information of all the applicants who had actually appeared in the exam held on 17.7.2016 for the position of Technical Assistant (T-3) to visit the websites of all the institutions where they had applied/opted to obtain their marks/position in the list of successful/unsuccessful applicants. In the rare event of an applicant having scored higher marks than the applicant finally recommended for an institution for which he had opted feels he/she left out in the draft merit/reserve list, he/she may bring it to the notice of the concerned Director of the institution alongwith all supporting documents like admit card etc. to establish his/her claim **on or before 28.02.2018.**
